CONSULTATION RESPONSE TO THE WELSH GOVERNMENT ON REVISIONS TO CHAPTER 7 OF PLANNING POLICY WALES – SUPPORTING THE ECONOMY

Purpose of Report

To request Members consider and respond to the Welsh Government's consultation on Revisions to Chapter 7 of Planning Policy Wales – supporting the economy.

Introduction

The consultation seeks views on the Welsh Government's proposed update to national planning policy on supporting the economy, which takes into account many of the recommendations contained in a research report "Planning for Sustainable Economic Renewal" produced by Roger Tym and Partners and Asbri Planning in 2011. The intention is to align policy more closely with the Welsh Government's broader economic policies and try to ensure that the planning system facilitates economic renewal in Wales more effectively.

The Main Changes

The Welsh Government has a legal duty to promote sustainable development – which is comprised of 3 components. The research paper, cited above, highlighted that under certain circumstances there is a perception that the economic component of sustainable development has been overlooked in the decision-making process at the expense of economic and social progress in Wales. The revised policy seeks to redress this perception by stressing the importance of economic redevelopment within the context of sustainable development.

Local planning authorities are required to adopt a more holistic approach to economic development, adopting a 'whole economy' approach by recognising that most development has some economic impact. The needs of the entire economy should therefore be considered including retail, leisure, tourism, sport, recreation and other services as well as the traditional employment uses defined under parts B1 to B8 of the Town and Country Planning Use Classes Order.

The changes focus on the need to ensure that sufficient land is not only available for economic and employment growth but that it is deliverable. This is in line with the procedure for producing Local Development Plans which will deliver identified development proposals within the Plan period. To ensure this, local planning authorities will now be expected to undertake and keep up to date Employment Land Reviews at a local and strategic level in collaboration with other authorities.

As well as ensuring an adequate supply of land the requirement will be to guide and control economic development to facilitate regeneration and promote social and environmental sustainability and to steer economic development to the most appropriate locations, rather than prevent or discourage it.

The policy direction for rural areas is to recognise the contribution that small-scale enterprises and new businesses can bring to the local economy, but also to recognise the need for them generally to be located within or adjacent to defined settlement boundaries. Support should also be given to the expansion of existing businesses in the countryside and the positive approach to farm diversification remains.

The guidance supports the encouragement of a green economy with clustering of industrial and commercial uses benefitting from co-location and favourable consideration of on-site energy consideration.

Consultation response

The Welsh Assembly has prepared a questionnaire for completion in response to the consultation. A draft response has been prepared and is attached to this report as Appendix 1.

Recommendation

That Members of the Development Management Committee consider and approve the attached response to the Welsh Government's consultation on Revisions to Chapter 7 of Planning Policy Wales.

Please refer to National Park purposes, as defined in the 1995 Environment Act which are:

- To conserve and enhance the natural beauty, wildlife and cultural heritage of the National Parks;
- To promote opportunities for the understanding and enjoyment of the special qualities [of the National Parks] by the public.

These are underpinned by the Sandford Principle which asserts the primacy of the first purpose over the second in cases of irreconcilable conflict. A duty to foster the economic and social well being of local communities within the National Park should be fulfilled in the pursuit of Park purposes.

Local development plans are written in accordance with national planning policy, with any differences justified. The local development plan is evidence based and receives thorough testing through the examination process. It also provides for certainty wherever possible. With the Annual Monitoring Report and Plan Review process in place, these mean that local development plans will soon reflect any revision made to Chapter 7 of Planning Policy Wales (or provide justification why they do not do so). The statutory framework to ensure compliance with the local development plan also allows for other material considerations to be taken into account for individual planning proposals. The statement made in para 7.6.2 of the consultation document has the potential to undermine the strategy within an area as it would remove the ability to consider the cumulative impacts of individual planning applications.
